- 1. Item 8 of Exhibit D should have the following items added:
 - 1. Animals must be directly supervised or on a leash at all times.
 - 2. Owners must promptly pick up after their animals each and every time.
 - 3. If animals exhibit nuisance or threatening behavior a formal complaint may be filed by a member of the association with the Board.
 - 4. Owners will be allowed one complaint without penalty.
 - 5. One complaint will result in a written warning from the Board. After any additional complaints, the pet owner will be fined \$20 for each additional offense.
 - 6. If a resident deems a dog a danger to others, they may request an emergency board meeting be called.
 - 7. The board has the authority to request that an animal be removed from the premises.
